### **US Senate Votes to Possibly Suspend Restart Rule**

## **NEW CCF Regulation May 2014**

The Office of Management and Budget (OMB) has approved the 2014 Federal Custody and Control Form (CCF). The 2014 Federal CCF may be used as a paper form or electronic form (Federal eCCF) for HHS testing, but only as a paper form for DOT testing. DOT has not yet approved the use of an eCCF. The use of this Federal CCF went into effect on May 31, 2014, and the expiration date is May 31, 2017.

## FMCSA Issues Statement of Policy on **Adjudicated Citations**

The Federal Motor Carrier Safety Administration (FMCSA) announced in a Federal Register Notice that beginning August 23, 2014, motor carriers and drivers will be able to request the removal of roadside inspection violations from agency data systems to more accurately reflect outcomes of judicial proceedings. The updated policy will enable carriers and drivers to request, through the DataQs system.
